The Etowah County Board of Education held its monthly meeting Dec. 2 at 5 p.m., recognizing outstanding achievements and approving several district initiatives and personnel actions.

Board President Jay Freeman called the meeting to order, and Vice Chair Tim Womack opened with prayer.

Superintendent Dr. Alan Cosby welcomed attendees and recognized Gadsden Regional Medical Center CEO Michael Hall, CFO Candy Garmany, Marketing Director Will Mackey and COO Brandon Nelson. Their team and hospital, serving as Kindness Council members of the 501(c)(3) charity neighborhood bridges, donated supply backpacks to all school nurses in the system.

Etowah County Lead Nurse Dawnya Duke and Jennifer Mc-Griff, executive director of neighborhood bridges of Etowah Countv. emphasized the importance of nurses being prepared on the go as first responders. Cosby praised the county's school nurses, calling them "unsung heroes."

The board approved minutes from the Nov. 7 meeting. Questions may be directed to board secretary Monica Snead.

Chief School Financial Officer Susan Bishop presented financial statements showing an unreserved fund balance 3.83 months as of Oct. 25, 2025. The board unanimously approved the budget anal-

Board meeting dates for 2026 were unanimously approved on a motion by board member Danny Golden and seconded by member Tim Langdale.

Revisions to the federal pro-

grams policy, updated job descriptions for the director of student services, counseling and accountability, and director of academic support services were all approved unanimously on motions by Womack and Golden.

During recognitions, Sardis Middle School Assistant Principal Clint Brannon was honored as District 6 Assistant Principal of the Year. SMS Principal Chris Royal praised Brannon's role in initiatives that helped increase the school's academic report card

Faculty, staff and students at John S. Jones Elementary School celebrated their exceptional state report card score of 97 with a schoolwide event.

Principal Jenny Ryals said several teachers asked to recognize the 67th day of school because of a "six-seven" trend among students. "We decided to build off of that, and our faculty and staff took the vision and ran with it," Ryals said. "What's better than 67...97!"

The celebration included confetti, a balloon drop and cake. Each grade-level faculty team also chose a walkout song as they took a victory lap in front of the student body. Ryals said the child nutrition program, custodial, resource and support staff joined in as well.

"True academic excellence is a full school culture," she said. "All of our faculty and staff are part of the success at John S. Jones, so we made sure everyone was part of the celebration.' Ryals said the school has a decades-long record of aca-

demic excellence. "We have always been a leader in our school system and in Etowah County at large," she said. According to Ryals, the school spent last year restructuring its Professional Learning Communities to strengthen

teachers' understanding of grade-level state standards. "We have been very purposeful in both identifying essential standards and breaking them down to better understand the skill sets each standard encompasses," she said. "This allows us to pinpoint student mastery and better remediate and enrich learning at individual levels."

December is a leading month for U.S. home fires

The holiday season is often touted as the most wonderful time of year, but it also presents an increased risk of home fires. According to the National Fire Protection Association (NFPA), December is a leading month for U.S. home fires, with Christmas Day and Christmas Eve representing the second- and third-leading days of the year for home cooking fires, respectively, in 2024.

"Many of the activities we engage in during the holiday season reflect leading causes of home fires, which explains why we consistently see the number of home fires climb at this time of year," said Lorraine Carli, vice president of Outreach and Advocacy at NFPA.

While cooking significantly contributes

to the increased risk of home fires during the holiday season, other contributing factors include Christmas trees in the home, the use of holiday decorations, particularly those involving candles or electrical lighting, and the use of heating equip-

NFPA's latest statistics (annual averages between 2020 and 2024) underscore the factors that collectively contribute to the December spike in home fires:

Cooking is a leading cause of reported U.S. home fires, home fire injuries, and deaths. An estimated 48 percent of home structure fires, 35 percent of home fire injuries, and 16 percent of home fire deaths involved kitchen and cooking equipment.

Unattended equipment is a factor in an estimated one-quarter (25 percent) of reported home cooking fires and nearly half (43 percent) of the associated deaths. Thanksgiving is the leading day for home cooking fires, followed by Christmas Day and Christmas Eve.

Heating

Heating equipment is another leading cause of U.S. home fires with nearly half (46 percent) of all home heating fires occurring from December through February. Space heaters and heating stoves were the type of heating equipment responsible for the largest shares of home heating equipment fires, accounting for nearly half (47 percent) of the fires, seven out of 10 deaths (73 percent), and seven out of 10

injuries (70 percent). **Holiday Decorations**

U.S. fire departments responded to an estimated 835 home structure fires that began with decorations (excluding Christmas trees), resulting in three civilian fire deaths, 29 civilian fire injuries and \$18 million in direct property damage. Nearly half (47 percent) of these fires occurred because the decorations were too close to a heat source, such as a candle or other heat-producing equipment. Candle fires peak in December and January; 12 percent of candle fires occur in December and 10 percent occur in January.

JSU mourns passing of trustee emeritus Bob Kennamer

Jacksonville State University is mourning the loss of Bob Kennamer, Trustee Emeritus, alumnus, and one of the most dedicated servants in the university's history. Kennamer assed away Sunday morning, leaving behind a legacy shaped by leadership, loyalty, and an unparalleled devotion to the institution he cherished for nearly seven decades.

Kennamer enrolled at Jacksonville State in September 1955, attending what was then Jacksonville State Teachers College. As a student, he quickly became known for his initiative and involvement on campus, serving as Vice President and President of the Student Government Association and as a proud member of Pi Kappa Phi fraternity.

During his term as SGA President, he led the fundraising effort that re-established Jax State's baseball program, securing the equipment needed for Coach Frank Lovrich and his student-athletes to return to the field. He graduated in 1958 with a bachelor's degree in business administration and later became

the university's first single male dorm director while beginning graduate studies.

"Bob Kennamer truly loved Jacksonville State. You could see it in the way he supported our students, our programs, and the people who make this place special," said Jax State President Dr. Don C. Killingsworth, Jr. "He devoted his life to serving this university and the people who make it special. For decades, he gave his time, his energy, and his wisdom to help guide Jax State through times of challenge and times of tremendous growth. To me, he wasn't just a trusted leader-he was a dear friend. The impact of his service will be felt for generations, and we are a better university because of the life he lived."

After a successful career in insurance and real estate development, Kennamer continued to demonstrate the same dedication to service that defined his time as a student. In 1980, he was appointed to the Jacksonville State University Board of Trustees, where

he served for more than 26 years. Throughout that time, he provided steady, thoughtful leadership as the university experienced significant growth and change. He also served on the JSU Foundation Board as a founding member and on the SouthTrust Bank Board of Directors. His counsel remained invaluable long after he was named Trustee Emeri-

Kennamer's commitment to Jacksonville State extended well beyond his years on the Board. He remained deeply engaged in the life of the university, offering advice, supporting key initiatives, and helping strengthen programs across campus. He and his late wife, Lou, played an enduring role in expanding opportunities for students and enhancing the overall Jax State experience. In recognition of their dedication, the university honored them with the naming of Bob and Lou Kennamer Hall, and in 2006, Kennamer received an honorary doctorate from Jacksonville State University.

In 2009, Jax State Athletics honored Bob and Lou Kennamer with the Jimmy Bryan Award, recognizing their decades of dedication to Gamecock student-athletes. He was also a member of the university's Lifetime Leaders Society, reflecting a lifetime of involvement and service.

For all his accomplishments, it is his kindness, loyalty, and genuine care for others that the Jax State family will remember most. Generations of students, faculty, staff, coaches, and alumni were impacted by his encouragement and by the example he set.

As the Jax State family grieves this profound loss, we extend our deepest sympathies to those impacted by Kennamer's life. His legacy of service, leadership, and love for Jacksonville State will continue to inspire all who follow.

A Celebration of Life and Reunion of Friends will be held on Tuesday, December 9, at 3 p.m. at the Stone Center on the campus of Jacksonville State.

The school also worked to reduce chronic absenteeism, one of the three factors the state uses to calculate report card grades, along with student achievement and student growth.

"To us — and pardon the pun — it is elementary. Students need to be at school in order to grow and achieve," Ryals said. "So we targeted the needs of students who are struggling with attendance."

The initiative paid off. The Panthers improved by 1.39 points in student achievement and 0.74 points in chron-

ic absenteeism. In student growth, the school earned the maximum value of 45 points, achieving 100% growth for the past five report cards from 2018–19 through 2024-25.

Ryals said the school is already looking ahead. "We have set our sights on next year," she said. As bookkeeper Krista Weaver put it, "Next year when we get a 99—or 100—we will know what to do to celebrate even bigger."

Clots can happen: Learn risks, symptoms, prevention

Blood clotting is vital for recovery from injury, but when clots form and don't dissolve properly, they can block blood flow and cause serious health problems. On average, one person in the U.S. dies from a clotrelated death every six seconds.

Dr. Kerri Bally, a pulmonologist with Etowah Pulmonology Associates, said everyone is at risk for clots, regardless of age or gender. Pregnancy, cancer treatment, major surgery, or hospitalization for several days can increase the risk. Being overweight, having diabetes or high cholesterol, a family history of blood clots, smoking, or

being over 60 can also elevate the risk.

"Clots can occur suddenly, leading to reduced blood flow. The impact can be significant, even fatal," Dr. Bally said. "Symptoms vary depending on where the clot occurs — in the legs, arms, lungs, heart, or brain — but the need for timely medical care is consistent. There are more treatment options the sooner the blockage is identi-

Pain often occurs where the clot is located, whether in the arm, lower leg, or even the stomach. Sudden swelling in one limb could also be a warning sign.

With deep vein thrombosis, when a clot forms in a large vein such as the lower leg or arm, there is concern it could travel to the lungs. Symptoms may include sudden swelling in a limb, pain or tenderness not caused by injury, or skin that is warm, red, or swollen.

A pulmonary embolism occurs when a clot blocks blood flow in the lungs. Symptoms may include a fast pulse, chest pain that worsens with deep breaths, bloody cough, shortness of breath, or an irregular heartbeat. In some cases, the first symptom is sudden death.

Seek medical attention immediately if you experience any of these symptoms. A medical exam can determine the cause, and a provider may recommend a diagnostic scan. Certain medications can break up or dissolve clots if administered within hours of symptom onset.

"Your best bet in preventing clots is knowing and managing your risks," Dr. Bally said. "There are a number of actions you can take to support your health."

Dr. Bally recommends regular movement to help prevent clots. Avoid sitting or remaining still for long periods, especially after a long flight, travel, or surgery. At a desk, flex your legs, feet, and toes, and get up to move frequently. If extended sitting is unavoidable, consider wearing compression socks or clothing. Patients should discuss clot prevention with their doctor before surgery and review whether preventative medication is needed if they have risk factors.

Basic health measures also apply: eat a heart-healthy diet, maintain a healthy weight, manage stress, and control chronic conditions such as high blood pressure, high cholesterol, and diabetes

Cosby reiterated items first presented Nov. 7, including installing weapons detection systems in all county high schools and LED lighting upgrades at football stadiums. The board also approved purchasing the ConnectWise remote monitoring system for the technology department.

Personnel actions were approved unanimously. Whitesboro Elementary Principal Mary Beth Gilliland attended in support of the school's newly approved secretary/ bookkeeper, Elissa Tarvin Huerta.

The board also approved TEAMS contracts for the 2025-26 school year, faculty and non-faculty supplements, new substitute teachers, additional resignations and retirements, and extended congratulations to all new personnel.

Cosby closed Tuesday's meeting by announcing he will retire as superintendent of Etowah County Schools on April 1, 2026. Cosby said it has been "the honor of a

Hokes Bluff Middle School, led by lifetime" to lead and serve the Etowah Principal Dr. Beverly Neal and Assistant County Schools community for 33 years, including 16 as superintendent. He said he is proud of the accomplishments he and the district have achieved together, including earning an A on the state academic report card and maintaining strong financial stability across the system.

> He said it has been a privilege to work alongside students and employees who "consistently set high standards," and noted he has been fortunate to serve with dedicated and supportive board members throughout his tenure.

> "I'm deeply grateful for the collaborative spirit that has defined all these years. Etowah County Schools are a treasure and the future remains exceptionally bright," Cosby said, adding that he remains committed to ensuring a smooth transition as the board prepares for new leadership.

> Cosby called his decision to pursue other opportunities bittersweet. He thanked his wife, Jeannie, for her support and said he appreciated the confidence board members placed in him when he was hired in March

> He said the district has accomplished much during his tenure and promised more progress in the remaining four months before his retirement.

> The meeting concluded with a standing ovation for Cosby and his years of service.

Christmas tree fires don't happen very compatible with your device. To be safe, more serious. U.S. fire departments responded to an average of 143 home fires that started with Christmas trees, resulting in an estimated seven civilian deaths, 13 civilian injuries, and \$15 million in property damage. Nearly one in four (24 percent) Christmas tree fires were started by lamps or bulbs. Eleven percent were started by candles. Electrical distribution or lighting equipment was involved in 40 percent of home Christmas tree fires.

Lithium-Ion Batteries Many people will be buying and gifting electronic devices that contain lithiumion batteries. As the use of these devices has increased in recent years, so too has the number of related fires. It's important to understand the risks associated with

these batteries and ways to prevent them: Only purchase and use devices, batteries, and charging equipment that are listed by a nationally recognized testing

lab and labeled accordingly. Use charging equipment that is only

often, but when they do, they tend to be use only the charging equipment that is supplied with your device. Do not keep charging the device or de-

vice battery after it is fully charged. Do not put lithium-ion batteries in the trash. Recycling is always the best option. Take the batteries to a battery recy-

cling location or contact your local waste department for disposal instructions. Stop using your device if the battery shows signs of damage, such as an

unusual odor, excessive heat, popping sounds, swelling, or change in color. Only have device repairs performed by a qualified professional.

Understanding where potential threats exist and taking the steps needed to prevent them can go a long way toward ensuring a festive, fire-safe holiday season," said Carli.



May we find little things that help us reset



This week, we finally turned on our "extra" heaters. These wall-hung gas heaters are a sensory throwback to childhood: the smell of a match, the click-clacking of the pilot button, and the immediate, blistering warmth. The cold is here, and after the storms, the fall leaves are officially off the trees and on the ground. Edith Sitwell describes it this way: "Winter is the time for comfort, for good food and warmth, for the touch of a friendly hand and for a talk beside the fire: it is time for home." The season for wintering is here.

Wintering is, in its practical sense, when many animals and humans either travel to warmer climates, or hunker down until the season passes. As we burrow into this sea-

son, blankets and sweaters and scarves at the ready, we have an opportunity to observe what truly is enough. Nature does not hold onto what is no longer needed. Leaves drop from trees, and the trees do not miss them. The squirrels and birds use and eat what they have. The landscape becomes less cluttered as the wind clears the trees, but the beauty doesn't disappear. Our very human tendency during this time, though, is to fill up all the spaces left by the season. We fill up visual space with holiday decorations. We fill up our pantries with supplies. We fill up our calendars with activities and parties. And, there is nothing wrong with celebrating the season and gathering with those we love. But, there is also no reward to be won for overburdening and exhausting ourselves.

Recently, my girls and I have been doing an evening reset. Busy days full of classes and homework and grading and bowling and holiday excitement can lead to dysregulation and frustration and tears. So, after dinner, we find a spot to sit and read, watch a show together, or journal, and have a cup of tea. This is my peak wintering.

With the busyness of the holidays, though, it isn't always feasible to go straight home and winter in solitude. Sometimes, a reset is needed in the middle of chaos, too. This week, I was in the middle of an out-of-town bowling alley, and there was a long break until our girls bowled. The place was over-crowded, and so loud it was hard to think. The youngest and I found a spot and sat down, and did our own little reset in the middle of the noise: a few deep breaths, tuning into a favorite show for a few minutes, some hugs, and a snack worked wonders. We didn't have to completely escape the situation, just regulate our response to it.


Sitwell was right about winter being a time for the comfort of home, but we don't always get that option when we need it. Some days, wintering looks like tea and books and blankets at home. Other days, we can find an inner homecoming in the middle of a busy bowling alley with a child leaning against us. Both of these show us that we don't need more to feel grounded and connected during the holidays. Taking a breath, giving a hug, listening to a song-all of these moments remind us what really matters, and how sometimes we don't need more time/blankets/space/quiet. We just need enough: "He who knows enough is enough will always have enough." Enough calm, enough presence, enough grace to know when to pause, breathe, and reset.

Robert Frost knew the power of this reset, and wrote about it in "Stopping by the Woods on a Snowy Evening": "Whose woods these are I think I know./ His house is in the village though;/ He will not see me stopping here/ To watch his woods fill up with snow.//My little horse must think it queer/ To stop without a farmhouse near/ Between the woods and frozen lake/ The darkest evening of the year.//He gives his harness bells a shake/ To ask if there is some mistake./ The only other sound's the sweep/ Of easy wind and downy flake.// The woods are lovely, dark and deep,/ But I have promises to keep,/ And miles to go before I sleep,/ And miles to go before I sleep."

As our days grow shorter, and the weather colder, may we find the little things that help us reset, re-center, and remember that usually we already have enough.

A public well on the court house grounds



Back in 1899 the local newspaper won its fight for a public well on the courthouse grounds when the county appropriated \$50, the city \$25 and some businessmen the remainder of the money. This was necessary to bore a well at the southeast corner of the courthouse under the bell tower — and the work actually started.

The contract called for a well "at least" 100 feet deep and six inches in circumference. The newspaper insisted for several years that the well was greatly needed beuse farmers coming to town to trade had no place to get a free drink of water.

The well was drilled to a depth of 105 feet through solid slate. When the vein was struck the holes was filled for 90 feet and stayed that way.

The water had a mineral taste with slate predominating. For a long time, the people thought it had medicinal qualities. Every hour in the day one or more persons came by to fill bottles and jugs in the belief that their health was being improved by drinking the water.

Then one day a laboratory test showed that it was polluted to a high degree and was actually a menace to the community. Many protested the decision, but the well was finally abandoned and filled in.

The newspaper that year was conducting a campaign against vagrants, claiming that they loafed on the courthouse steps and that some of them actually laid down on the steps and slept for hours.


It also complained that on the northside of Broad Street between Third and Broad Streets, the vagrants blocked the sidewalk in front of a hall and forced pedestrians bent on legitimate business to walk around them. Many resented this, and finally the city took action and kept the sidewalk clear.

In 1899 there was a baseball park at Eleventh Street and the L.& N. Railroad which was the scene of many good games.

There was no fence around the park, and the diamond and outfield were laid off on ground that was cultivated back in the early 1880. One recalled an interesting game in which Centre beat Gadsden by a score of 7

Shropshire, one of the editors of the Coosa River News, was an outfielder and the manager. He protested many decisions by the umpire and would run in full speed from centerfield to express his disgust at what he thought was a raw deal. He wore long hair in those days and while racing into the plate it bulged out in every direction. There were innings when he protested at almost every decision on balls and strikes and ran himself breathless. He was fair and honest himself and he demanded those qualities of everybody, including a baseball umpire.

A delicious mix of crab and pasta: Crapasta



One of my favorite joys in the kitchen is building meals that feel personal, something that speaks to the tastes of the people I love. Crapasta, a nod to the crab sticks he loves to snack on and the pasta that makes this dish so comforting.

I want them to feel at home in the kitchen, to know that they can create something delicious with their own hands. Crapasta is the perfect recipe for that. Simple steps, familiar flavors, budget friendly, and a result that feels special.

The best part of Crapasta isn't just the flavor; it's the memory of Gabriel standing beside me, stirring the sauce with determination, sprinkling cheese with a grin, and proudly serving a dish he helped create. It's a reminder that food is more than sustenance; it's connection, confidence, and joy.

- **Ingredients** • ½ stick (4 Tbsp) butter
- 2 cups mushrooms, sliced
- 2 Tbsp diced garlic
- 2 bags frozen cheese ravioli • 2 cups heavy cream
- 1–2 cups imitation crab sticks, cut into bite size pieces (or real crab, if you prefer)

• 2 cups shredded Italian blend cheese

- Salt & pepper to taste Optional: fresh parsley for garnish
- **Instructions** 1. Melt the butter in a large skillet over medium heat. Add mushrooms and garlic, sautéing until softened and fragrant (about
- 5–7 minutes). 2. While the mushrooms cook, bring a large pot of salted water to a rolling boil.

Add ravioli and cook according to package directions.

- 3. Stir heavy cream into the mushroom mixture. Let it simmer for about 10 minutes, reducing slightly.
- 4. Add shredded cheese and stir until melted into a creamy sauce. Fold in crab
- 5. Drain ravioli and add to the sauce. Toss gently to coat.
- 6. Season with salt and pepper, garnish with parsley, and serve warm.

Have you ever thought much about another person's fragrance or noticed how the environment shifts when someone enters the room?

According to Webster's Dictionary, fragrance is defined as a "pleasant aroma or a sweet smell." Ecclesiastes 7:1. "A good reputation is more valuable than costly perfume." Ecclesiastes 10:1 says "As dead flies cause even a bottle of perfume to stink, so a little foolishness spoils great wisdom and honor." Solomon explains that just as dead flies can destroy the sweet fragrance of a bottle of perfume, so foolishness and the lack of wisdom can destroy our good name and reputation. Our fragrance is reflected by what we fill our minds with and the choices we make each day.

2 Corinthians 2:15-16. "Through our yielded lives he spreads the fragrance of the knowledge of God everywhere we go. 
But what if we shifted our perspective? What if instead of seeing these as overwhelming burdens, we recognized them as evidence of God's favor in our lives?







Coosa heads to state championship

The Coosa Christian Conquerors have conquered the attention of Etowah County as they prepare to compete for the AHSSA Super 7 Football State Championship this Friday.

Coosa Christian (12-2), coached by Rush Propst, secured a 44-36 victory over Pisgah (11-3) on Friday, Nov. 28, to clinch a berth in the Class 2A semifinals. Propst is making his first appearance in the AHSAA state finals since 2006. He guided Hoover to the 6A championship game sevenstraight years from 2000-2006.

Since Coosa's first team formed in 1976, the school has made 13 play-off runs. The Conquerors last made it to the championship finals in 2023, where they lost to Leroy.

The last two seasons have been plagued with fines and forfeitures

for Coosa Christian, with the Conquerors forfeiting five games in 2023 due to violations of the AHSAA Transfer Rule and with the team forfeiting five games in 2024 and being placed on restrictive probation ahead of the 2025 football season for playing an ineligible player in violation of the AHSSA's Coaching Outside School Year Rule.

Prior to the start of the 2025 season, Coosa announced that then-head coach Mark O'Bryant was suspended to meet all terms of the AHSAA's probation ruling concerning violations in the school's football program. Hokes Bluff takes on Boaz and Geraldine

Hokes Bluff's basketball teams tallied up some big mileage earlier in the week as they traveled on both Monday and Tuesday to Boaz and Geraldine, respectively. Early season matchups are obviously pivotal in preparing teams for area play, and each of these opponents are unique compared to Hokes Bluff's non-area slate from a season ago.

Hokes Bluff's varsity girls, led by Head Coach Evan Talbot, got off to an extremely slow start against Boaz. The Pirates didn't fare much better. Each team primarily utilized zone defenses for most of the contest, which can usually lead to a lot of three-point attempts and quick entries into the paint. However, each team shot poorly in the opening two quarters, leading to an uneventful halftime score of 10-9 in favor of Boaz.

Each team started to find its footing in the second half, though. The Lady Eagles connected on six threepointers in the game, but five of those came in the second half. Boaz responded to each mini-run that Hokes Bluff made, and it came down to Lady Eagles junior Mary Davenport sinking a crucial free throw with 4 seconds remaining to secure the 35-31 Hokes Bluff victory. Hokes Bluff's senior guard Pressley Wall led the team with 10 points. Addison Simmons, a sophomore forward, added 8 points of her own, and Mazely Ball, a freshman forward, had 6.

The varsity boys contest was played in stark contrast to the girls game, with points pouring in early and often from both sides. Boaz took a 14-13 lead into the second quarter, and that's where they separated themselves from the Eagles. After the opening quarter, Boaz outscored Hokes Bluff 53-34, leading to a 67-47 win. For Hokes Bluff, the lone bright spot came in the form of senior guard Ronan McFadden, who led all scorers with 27 points.

The following night at Geraldine, the Lady Eagles started out on fire. They raced out to a 16-4 lead at the end of the first quarter. For the rest of the game, Hokes Bluff would not allow their lead to get any less than 15, and cruised to a 56-32 victory, the sixth win in a row for the Lady Eagles (6-1). Addison Simmons led the team with 12 points, and senior forward Emma Doss added 9 of her own. Mazely Ball also scored 9 points.

The Hokes Bluff boys team got a little of their groove back against the Bulldogs, but it was far from an easy feat. It was a tight contest for much of the first three quarters, with neither team being fully able to pull away from one another. However, the fourth quarter was all-Hokes Bluff. The Eagles' senior guard, Noah Johnson, got hot in the closing minutes and helped stretch their lead to double-digits. He would go on to finish with a game-high 24 points. The Eagles held on to their lead until the final buzzer sounded, giving them a 53-41 victory. Ronan McFadden chipped in 8 points, and freshman forward Brody Morgan added 7.

Both Hokes Bluff teams will play again tonight at home against their crosstown rival, Glencoe. The junior-varsity girls game will start the action at 3:30, with all other games to follow.




